SCHEDULE 1 : NOTES TO ACCOUNTS

SIGNIFICANT ACCOUNTING POLICIES :

1. System of Accounting:

The books of accounts are maintained under historical cost convention on cash basis.

Revenue is recognized on receipt and expenses are accounted on payment.

2. Immovable Properties:

Immovable Properties are stated at cost of acquisition / construction and improvement thereon.

3. Building under Construction:

The cost of construction is arrived at by including the direct cost of construction as certified by the Chartered Engineer and Architect.

4. Investment:

Investments are stated at cost of acquisition.

5. Donation to Trust Fund and Corpus:


Donations to Corpus are directly transferred to Trust Fund & Corpus.

6. Sinking and Depreciation Funds:

An amount calculated at 5% on written down value of immovable properties is transferred to Sinking and Depreciation Funds.

7. Class II Khatas :

The Trustees of the Parsi Punchayet are the custodian trustees of investments and other assets of Class II Khatas which are held in their custody and for which separate accounts are being maintained and are sent to the respective custodians of Class II Khatas.
